**Southern Insurance Companies is an comprised of several companies formed to service the needs of independent insurance agents and their customers. Southern Insurance Underwriters, originally chartered as Kurt Hitke and Company, was established in 1926. Kurt Hitke was the first individual to start writing "hard-to-place" risks which, in those days, were called substandard business.**

He began by writing taxicabs in Chicago in 1926 and started expanding the company's operations in 1949. By the mid-1950s, with a total of nine offices, SIC had become the largest writer of substandard business in the US. The National Underwriter, a leading trade journal, described Hitke as "the creator of substandard underwriting" upon his retirement in 1964. W C Duesenberg, Sr. purchased the company and changed the name to SIU. Today, Wes Duesenberg, Jr. and Tripp Duesenberg represent the second and third generations of this family-owned business.
